## Transportation

Parents are responsible for transportation of the campers to and from the camp. Arrival for campers will begin on **Sunday, August 13<sup>th</sup>, at 3pm** and will continue throughout the day till 5:00pm. Camp will officially begin at 6:00pm. Please plan accordingly so that your child will arrive at Camp Sankanac at some point during this time slot. On the last day of camp, **Saturday, August 19<sup>th</sup>**, parents will be responsible for picking up their kids. Camp will officially end at 2:00pm, so campers may be picked up anytime from **2:00 pm to 3:00pm**. Please be responsible for dropping off and picking up your children in a timely manner.
